Decisions taken by the Steering Committee:

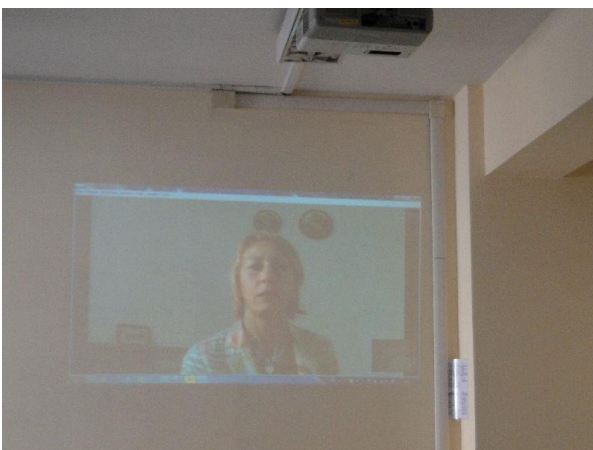
- approval of the 5th Quality Assurance Report
